#### **Description of necessary first aid measures**

Eye contact

Inhalation

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. #### **Environmental precautions**

#### Methods and materials for containment and cleaning up

### Small spill

# Appropriate engineering controls
