Section 4. First aid measures

Description of necessary first aid measures

Eye contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If it

Methods and materials for containment and cleaning up

Small spill


