### Description of necessary first aid measures

### Precautions for safe handling

### Appropriate engineering controls

: Use only with adequate ventilation. 


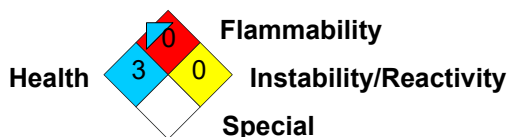
