Description of necessary first aid measures

Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). 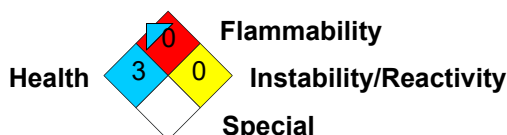
