## Section 5. Fire-fighting measures

### Methods and materials for containment and cleaning up

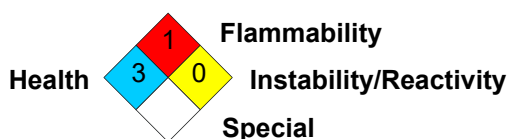
