## **Description of necessary first aid measures**

## Methods and materials for containment and cleaning up

### Small spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. ### Precautions for safe handling

### **Protective measures**
