#### **Description of necessary first aid measures**

#### Methods and materials for containment and cleaning up

Small spill

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

## Section 6. Accidental release measures

#### Large spill

#### Precautions for safe handling

#### **Protective measures**

Do not enter storage areas and confined spaces unless adequately ventilated. ## Appropriate engineering controls


