Section 4. First aid measures

Description of necessary first aid measures

Eve contact

: Eet medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Methods and materials for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures
